It was a critical and important speech, and I'm grateful that the Center invited me to speak at their forum. I want to focus today on one theme in my speech and explain why I believe it is wrong and unconstitutional: President Obama's executive actions on guns. Now, to put my point into context, here is the background on what President Obama has done, where things stand now, and what should happen next. In early January, President Obama issued 23 executive actions to expand background checks, ban certain ammunition magazines, and to fix "deficiencies in the [federal background check] process." There are eight states that have chosen to accept those new rules and 16 states that haven't. The new rules allow the federal government to access confidential mental health records, and under the 1994 Brady Law, they are supposed to enable a background check of any "prohibited person." But there are big problems. And it's these problems that I want to focus on today. Let's start with the background check. Under federal law, if you receive a firearm from a licensed dealer, you're supposed to have your name run through the federal background check system. But when the president's new rules came into effect, over 350,000 weapons were sold to people who weren't subject to the background check because of failures in 2d92ce491b
